## Politics and Governance

Saba Kassa

This key area addresses the challenge of understanding the interplay between how society wants to live (politics) and the coordinated action (governance) undertaken to make this possible. The members wish to focus less on the state and more on the actions and practices constituting contexts of politics and governance. In addition, the KAA acknowledges the importance of knowledge that addresses practical problems, especially since these problems and policy issues are an essential source of inspiration for identifying theoretical, conceptual, and methodological challenges.

### Addressing bribery and corruption

The research team at the Basel Institute on Governance finalized the joint research project on "Addressing Bribery and Favouritism in the Tanzanian Health Sector: A Behavioural Approach." The mixed-methods evaluation aimed to understand the feasibility and potential impact of a multi-component behavioral intervention on rates of gift exchange between users and staff of a public regional referral hospital in Dar es Salaam, Tanzania. Moreover, the Basel Institute on Governance led various anti-corruption technical assistance projects in Eastern and Southern Africa and shared findings from ongoing research on anti-corruption, the role of social norms and networks, and its intersectionality with health and environmental governance in Africa in various practitioner-orientated events.

The Basel Institute on Governance research team will prepare spin-off publications of its recently completed research project on addressing corruption through a social norms approach in Tanzania. In addition, the team will seek to secure follow-up funding to explore how to scale up the successful pilot interventions and how such an approach might be adapted to address corruption problems in other sectors. Moreover, they will continue their anti-corruption prevention work with national anti-corruption bodies in Africa.

# African Megachurches in Hong Kong and Switzerland

Andreas Heuser at the Faculty of Theology of the University of Basel continued the implementation of a Bridging Grant project on "Political Theology in African Megachurches in Hong Kong and Switzerland" (Leading House Asia/ETH ZH). The project runs from September 2021 to February 2023.

# Peace Agreements in the African Peace & Security Architecture

In 2022, Michael Aeby, a graduate of the MA African Studies at the University of Basel, joined the ZASB with an SNF postdoc return grant. His research project is designed to make a crucial empirical contribution to the Area Studies literature on peace-making in the African Peace and Security Architecture (APSA) and prepare a collaborative multiyear project. The study generates policy-relevant comparative insights on the ways the African Union (AU) and Regional Economic Communities (RECs) support the implementation of Comprehensive Peace Agreements (CPAs) in intrastate conflicts. In the framework of his fellowship, Michael Aeby co-convenes the online colloquium of the of the African Politics Research Group (APRG) in collaboration with the University of Edinburgh. The colloquium serves as a platform for PhD candidates, postdocs and established scholars with various disciplinary backgrounds who are based at universities in the North and South to discuss ongoing and recently completed research.

# Collaboration with ABI and ACT in Freiburg

Activities by members of our key area contribute to the ZASB's exchange and collaboration with the Arnold-Bergstraesser-Institut (ABI) and the Africa Centre for Transregional Research (ACT) of the University of Freiburg (Germany). In 2022, the ACT became a full member of the African Studies network in Europe, AEGIS, of which the ZASB is a long-standing member. Julia Tischler, co-director of the ZASB, is the chairperson of the ACT advisory board.

The ACT organized the international biennial conference of the German African Studies association, VAD, in Freiburg in June 2022 on "Africa-Europe: Reciprocal Perspectives". The ZASB was actively involved in various ac-

tivities, including the roundtable "Concepts without Borders" and several panels, as well as a reception at the conference venue and a concert at the Jazzhaus on the first conference day. The ABI organized the adjacent Young Scholars' Day.

The ABI continued a provenance research project on returning human remains from Africa in the Freiburg University collection attributed to Alexander Ecker. Members of the ZASB and Basler Afrika Bibliographien will be involved in the final conference as the project will conclude in April 2023 with the handover of a policy paper to the authorities.

As of 1 January 2023, the ACT takes over the administrative role formerly attributed to the Freiburg Institute for Advanced Studies (FRIAS) with regards to the Maria Sibylla Merian Institute for Advanced Studies in Africa (MIASA) at the University of Ghana, a project funded by the German Federal Ministry of Education and Research. The mid-term conference of MIASA will take place in September 2023. Elísio Macamo, who is a member of MIASA's academic advisory board, will convene a panel together with Andreas Mehler and Mamadou Diawara (University of Frankfurt).

### Outlook

A primary objective of this key area in 2023 is to explore synergies in research collaboration. The ZASB workshop planned for March 2023 will kick-start this process.

### Supporting the Implementation of Peace Agreements in the APSA

The African Union (AU) and Regional Economic Communities (RECs) have facilitated numerous peace agreements in intrastate conflicts since they initiated the joint African Peace & Security Architecture (APSA) in 2002. However, most agreements collapse instead of being implemented, for reasons that are often beyond the control of external sponsors. However, in order to render their peace-making efforts more sustainable, the AU and RECs must improve their ability to support the implementation of agreements that are facilitated by their mediators.

Peace Studies literature shows that third parties can support implementation through continued mediation, guarantees and monitoring. AU policies recognize the importance of implementation support, but the APSA building blocks' use of mediation, guarantees and monitoring to support implementation in practice has yet to be systematically researched in order to inform policy and peace-making practices.

This project, therefore, examines how the AU, Intergovernmental Authority on Development (IGAD), Economic Community of West African States (ECOWAS) and Southern African Development Community (SADC) support the implementation of comprehensive peace agreements and framework agreements for transitions through continued mediation, guarantees and monitoring. It reviews the four organizations' policies and structures, traces implementation support practices in selected peace processes, and compares commitments for third-party support in 30 agreements. The twelve-month-long postdoc project is financed by the Swiss National Science Foundation (SNSF).

## Health

Andrea Kaiser-Grolimund

Danelle van Zvl-Hermann The key area with the broad name "Health" brings together researchers from different disciplines and at different stages of their academic careers. A particular focus of the key area is on the exchange and critical conceptual and epistemological reflection of health-related themes explored from different disciplinary perspectives, including both the social and natural sciences. Our members represent various faculties and departments of the University of Basel as well as affiliated institutes, in particular the Swiss Tropical and Public Health Institute.

### Restructuring of health-related key areas

In 2022, we revised the structure of the health-related key areas. At the Steering Committee meeting in June 2022, Sonja Merten, Martin Röösli and Andrea Kaiser-Grolimund put forward the proposal to merge the two previous health-related key areas "Public Health, Ecosystems and Wellbeing" (chaired by Martin Röösli) and "Control of Neglected Tropical Diseases and Diseases of Poverty" (chaired by Claudia Daubenberger) into a new broad key area, comprising various sub-themes reflecting the current and future work of the ZASB members in the field of health.

With this restructuring, we hope to facilitate interaction between different groups and disciplines. The formation of subgroups in the future will also allow for more flexibility in the inclusion of new projects and individuals, and encourage exchange between and within these subgroups. The new key area is co-chaired by Andrea Kaiser-Grolimund and Danelle van Zyl-Hermann.

### The role of animals in people's livelihoods

ALIVEAfrica is a five-year multi-country study funded by the European Research Council (Starting Grant 2020, awarded to Hannah Brown, Durham University). The project is a collaboration between Durham University, the University of Nairobi, Njala University and the Swiss Tropical and Public Health Institute and explores contemporary animal-based livelihood strategies in sub-Saharan Africa with ethnographic case studies in Kenya and Sierra Leone. At Swiss TPH, Jakob Zinsstag is involved in the project as an advisor, while Andrea Kaiser-Grolimund's postdoctoral project explores global assemblages of One Health by studying the production of knowledge, ideas and policies related to One Health using a multi-sited ethnographic approach.

#### **Pesticides: Continuation of APSENT**

The African Pesticide Intervention Study (APSENT) was initiated in 2020 with the overall goal to obtain a better understanding of ongoing research and public health activities related to pesticide interventions in Africa, and to provide a basis for suitable interventions targeting specific situations. In the framework of this project, Peter Ssessekkade joined the Swiss TPH as a PhD student for three years on an ESKAS fellowship. He is working on the APSENT-Uganda data to evaluate the impacts of a two-day training and SMS intervention on knowledge, attitudes and practice of pesticide handling in Uganda.

#### Consolidated key area of activity

The key area "Health" held its first meeting in November 2022 to discuss the future of the group together with additional interested ZASB members. Representatives of diverse disciplinary backgrounds such as molecular parasitology, molecular epidemiology, social anthropology, medical anthropology, nursing science, law, (African) history, medical history, social history, sociology, development policies and politics, epidemiology, exposure assessment, agriculture, theology, biomedicine, cardiovascular science, public health joined the group and are based at different faculties and departments at the University of Basel and the Swiss Tropical and Public Health Institute. At a workshop in January 2023 at Swiss TPH in Allschwil, the members presented their work and discussed ways of working together as a group and possible outcomes

# New SNSF grants: Agricultural health and artemisinin resistance

Samuel Fuhrimann won an SNSF Starting grant to start his research group around agricultural health in February 2023. A key focus will be on the establishment of comparative cohort studies with farmer families and the assessment of their health and well-being in Uganda, South Africa and Switzerland over the next five years. The SNSF starting grant will also provide a platform for interdisciplinary research on agricultural topics in Africa related to health as well as environmental and socio-economic aspects of farming. The underlying vision is to investigate the sustainability of conventional and organic farming systems along the global transition of agricultural systems.

From July 2023, a new SNSF SPIRIT project will be conducted in collaboration with Swiss TPH and the Rwanda Biomedical Centre (RBC). The main goal is to monitor the spread of antimalarial drug resistance in the country, by establishing an in vitro parasite culture laboratory to monitor parasite susceptibility to antimalarial drugs, and genomic tools to monitor molecular markers associated with antimalarial drug resistance and parasite genetic diversity. The project will be coordinated by Christian Nsanzabana at Swiss TPH and Aline Uwimana at RBC.

#### Outlook

At the key area's January workshop, members highlighted conceptual discussions as a shared agenda. A writing project is planned for 2023 with the aim of publishing a special issue with short contributions critically discussing key concepts from the field of public health from different analytical perspectives.

A student group led by Regina Molomo and Andrea Graf was established in order to bring together PhD and MA students from different faculties and disciplines in health.

# Knowledge Production, Forms, and Platforms

Julia Tischler

Scholars collaborating in this key area address the question of knowledge production on Africa. What are the conditions for producing knowledge on Africa, and how do these affect our research agendas as well as outcomes? For whom do we produce knowledge on Africa? How do we deal with the asymmetries that continue to characterize African Studies, in which Northern institutions and researchers play a dominant role? What does it mean to produce "postcolonial" knowledge on Africa? How can our research inform broader public debates?

### Reversing the Gaze

The SNSF Sinergia project "Reversing the Gaze: Towards Post-Comparative Area Studies" brings together researchers at the Department of Social Sciences (Elísio Macamo) and the Institute for European Global Studies (Ralph Weber) at the University of Basel with colleagues at the University of Zurich (Department of Geography) and the University of Edinburgh (School of Law). The project "reverses the gaze" by testing the analytic purchase of concepts developed in the Global South on political crisis phenomena in Europe. In 2022, members of the various work groups conducted research in Austria, India, Italy and Switzerland.

In June 2022, the project held a research workshop with project fellows and invited experts from Germany, India, Italy, Mozambique, Sri Lanka, the UK and USA with a focus on Conceptual Vocabularies and Epistemic Stakeholders. The workshop was tagged to the biennial conference of the German African Studies association VAD in Freiburg i.Br., where the project organized a round table on "Concepts without borders - Reciprocating analytical perspectives" with project members and fellows. Over the course of the year, the project's work groups organized additional (hybrid) workshops on "The Philosophy and Global Politics of Concept Travel" (Basel, June 2022), "Researching the un/familiar" (Basel, October 2022), "Decoloniality and the Politics of the Urban" (Edinburgh, October 2022), and "The Cultural Life of Democracy" (Zurich, November 2022).

In addition, the project continued its bi-weekly online colloquium titled "Working with the State" (spring semester 2022) and "Concepts without Borders" (fall semester 2022) with presentations by both project members and guest lecturers (including Geeta Patel, University of Virginia; Harshana Rambukwella, Open University of Sri Lanka; Rose Marie Beck, Universität Leipzig).

#### **African Contributions to Global Health**

The Sinergia-Project "African Contributions to Global Health", a collaboration between the Department of History (Julia Tischler), Swiss TPH (Jürg Utzinger), and EPFL (Jérôme Chenal), examines the (non-)circulation of knowledge in the field of health between the Global South and North. In 2022, researchers were conducting and mostly finalizing their research in Togo, Burkina Faso, Kenya, Côte d'Ivoire, Tanzania, and Zambia, among others.

In November 2022, team members organized a first "Stakeholder and Dissemination Workshop" in Nairobi, Kenya. The workshop consisted of several meetings in two informal settlements in the city, in order to share and discuss research results on topics such as access to water, sanitation, and healthcare. In addition, one larger session facilitated a dialogue between the Swiss and Kenyan research teams as well as local decision-makers, including the Nairobi City Council. These efforts form part of Vitor Pessoa Colombo's PhD thesis on urban health in Nairobi and Abidjan (supervised by Jérôme Chenal, EPFL, and Jürg Utzinger, Swiss TPH).

Moreover, the team launched the interdisciplinary MOOC "Examining African Contributions to Global Health" under the aegis of Tanja Hammel, who also offered blended-learning course based on the MOOC.

### **Equatoguinean Spanish**

Members of the SNSF-funded project "Improving the visibility of Equatorial Guinea as a Spanish-speaking country", directed by Sandra Schlumpf, have conducted fieldwork and further advanced their research in 2022. The project aims to describe the situation of Span-

ish in Equatorial Guinea from a sociolinguistic and dialectological perspective. It highlights the importance of Equatorial Guinea within Spanish language studies and thus helps to increase its visibility as a Spanish-speaking country. A critical, postcolonial approach to analysis aims to revise classical, Eurocentric patterns of description and to grasp and appreciate this African variety of the Spanish language in its specific context. The project thus contributes to the reorientation of Hispanic studies towards a globally-oriented perception of the Spanish-speaking world.

#### **Outreach activities**

From January to May 2022, Isabelle Chariatte (French Studies) organized a course at the high school (Gymnasium) in Liestal on "Fiction(s) et réalité(s) de l'Afrique". The course included sessions with the Chadian writer Noël Ndjékéry and with Jean Nordmann, former ICRC delegate, as well as a guided tour in the Basler Afrika Bibliographien. Funding could be secured from Movetia to teach a course on high school level with 'e-tandems' between students in Liestal and in Bowounda (Togo) in 2023.

Isabelle Chariatte also presented the Prix Ahmadou Kourouma to Osvalde Lewat (Cameroon/Switzerland) at the Salon du Livre Genève and moderated two readings at the Literaturhaus Basel with Leïla Slimani (Morocco/France) and Osvalde Lewat respectively.

In the framework of their "BAB Interviews and Conversations" podcast, the Basler Afrika Bibliographien published a podcast series (in German) on solidarity and anti-Apartheid movements in Switzerland. The four episodes feature extracts from interviews by Dag Henrichsen with key activists.

An interdisciplinary course at the Department of History taught by Tanja Hammel based on the research project "African Contributions to Global Health" resulted in articles by students that were published in the *Afrika-Bulletin* in November 2022.

# "Concepts without Borders – Reciprocating Analytical Perspectives" (Roundtable discussion at the VAD conference, June 2022)

The SNSF Sinergia project "Reversing the Gaze. Towards Post-Comparative Area Studies" hosted a roundtable session at the biennial conference of the German African Studies association VAD in Freiburg i.Br. Chaired by Elísio Macamo and Ralph Weber, the roundtable posed the question whether concepts – the most important resource available to social scientists – are hopelessly tied to context, bearer and normative assumptions. The standard assumption that concepts, when properly used, are independent of context has come under massive critique, especially in postcolonial and decolonial critiques. With Rose Marie Beck (University of Leipzig), Claudia Derichs (HU Berlin), Peter Ronald DeSouza (Goa University) and Patrício Langa (Eduardo Mondlane University), the roundtable brought together scholars from different disciplinary backgrounds and research contexts to explore the epistemological and methodological implications of deploying concepts in different regional and historical contexts.

In addition, members of the project convened two panel sessions on "The Politics and Epistemic Value of Positionality" (Lerato Posholi and Ralph Weber) and "Translating Concepts from Africa to Europe" (Tebuho Winnie Kanyimba and Matthias Maurer Rueda). # Land, Landscapes, and Ecology

### Aims and approaches

The key area "Land, Landscapes, and Ecology" focuses on the combination of three interconnected key themes in Africa-related research and debates in the humanities, social and natural sciences:

Land is a core topic in political struggles across Africa and beyond, and the question of who owns and can make use of land and natural resources more generally is fundamental to any socio-political analysis. Land-use practices are never isolated but always related to complex ecological, social, and cultural processes, which, in turn, are embedded in broader spatial and temporal frameworks.

The term "landscape", on the other hand, offers a theoretical perspective for discussing material and imagined (or practical and metaphysical) conceptions, through which land is shaped, perceived, experienced and understood. Landscape, therefore, is a concept that is reflected on in both the social and the natural sciences, and it opens up productive pathways towards interdisciplinary research.

Finally, the term "ecology" refers to the study of interactions between components within ecosystems and highlights the commitment to include biological, environmental and conservation science in our understanding of land and landscapes in Africa.

In sum, the key area "Land, Landscapes, and Ecology" offers a platform for thinking about the past, present and future of land and land use across the disciplines, based on a sustained interdisciplinary dialogue that seeks to synthesize theoretical and methodological approaches from natural science, social science and the humanities.

### Land use and landscape narratives

Since 2017, researchers from the fields of the social sciences, humanities and natural sciences based in South Africa, Namibia and Switzerland have worked together in the tri-national research project "Space in Time: Landscape narratives and land management changes in a Southern African cross-border region". The project aims to understand the changing landscape along the Lower Orange River/!Garib from various disciplinary angles. The project brings together key area members from different disciplines. Our common research questions seek, firstly, to identify changing land use and claims, secondly, to ask how these changes in land use and land claims affected the landscape, and, thirdly, how the landscape has reflected these changes.

After a one-year extension granted by the SNSF due to the Covid-19 pandemic, the project came to its official end in June 2022. We aim to conclude the project with an edited volume published open access gold standard by the Transcript Publishing House in Bielefeld in 2023. The University of Namibia Press has agreed to co-publish the edited volume as a printed version for Namibia and South Africa. Furthermore, we have produced a mobile exhibition which will tour the Lower Orange River region together with the UNAM publication in mid-2023.

### Land use and environmental impact

Heleen Vos started a pilot study on physical and chemical characteristics of anthropogenic and natural regions of the Kimberley Tri-Biome funded by a Leading House Africa Seed Grant. This is a follow-up of the SNSF/SSAJRP project (2017-2021) on South African cropland dust emission risks with a focus on physical thresholds, environmental and socio-economic impacts led in Basel by Nikolaus Kuhn of the Physical Geography and Environmental Change Research Group. The Kimberley Tri-Biome region has been selected by the South African Government as one of the research areas of the EFTON program, of which the Physical Geography and Environmental Change Research Group is a partner. Nikolaus Kuhn's research group also continued to contribute to the DEZA-funded Jijiga One Health Initiative under the lead of the Swiss Tropical and Public Health Institute.

Silva Lieberherr continued her work on supporting the fight against land-grabbing and workers' abuse in Liberia by highlighting and publicizing the role of corporate capital.

### Teaching and exchange

On the level of teaching we have launched a series of winter/summer schools in the framework of the "Learning for (Ex)Change" project, jointly organized with the University of Namibia. After several postponements due to Covid-19, two consecutive winter/summer schools were held in 2022. The first winter/ summer school focused on "Food Systems and the Environment - Transformations in Rural Namibia and Switzerland", and we conducted joint comparative fieldwork in Graubünden, Switzerland, and the Karas Region, Southern Namibia in February and May 2022. During the second one, a group of twenty students from both universities examined the "History and Legacy of Migrant Labor in Namibia and Switzerland" through joint projects in Namibia, Italy and Switzerland in June and July 2022.

The weekly Namibian and Southern African Studies research colloquium continues to be an important platform for the interdisciplinary work of our key area. The colloquium allows international scholars from various disciplines to come to Basel and offers students and faculty an opportunity for regular interdisciplinary exchange and debate. Since the fall semester 2020, the colloquium has been jointly organized with the University of Namibia as a hybrid online/on-site event and has since then become a pillar of regular academic exchange at student and faculty level.

## Outlook and planned activities

We look forward to various activities in research and teaching in 2023:

- The edited volume *The Lower !Garib Orange River. Pasts and Presents of a Southern African Border Region* will be launched, and an accompanying mobile exhibition is scheduled to be on tour in the Orange River border region from mid-2023.
- As a follow-up project of the successful "Learning for (Ex)Change" program, the Stiftung Mercator Schweiz has granted funds to produce an edited volume on the topic "History and Legacy of Migrant Labor in Namibia and Switzerland". The grant also enables former student participants of the

exchange progam to conduct independent field work and research for their contributions to the volume, which is scheduled to be published in 2024.

In addition, several individual research stays and scientific exchange visits are scheduled for 2023.

# Food systems and migrant labor: Two joint winter/summer schools in Switzerland and Namibia

In the framework of the project "Learning for (Ex)Change", two winter/summer schools for MA students took place in 2022, jointly organized with the University of Namibia. The theme of the first exchange in January and April 2022 was "Food Systems and the Environment –Transformation in Rural Namibia and Switzerland", with field trips taking place in Southern Namibia and Graubünden.

In June and July 2022, a second set of students engaged with the topic "History and Legacy of Migrant Labor in Namibia and Switzerland". Finally without Covid-19 restrictions, the participants of the second winter/summer school traveled along the historic routes of migrant laborers, first from the far North of Namibia to Windhoek, and subsequently from Italy to Basel.

In total, in 2022, 16 students from Windhoek visited Switzerland and 18 from Basel went to Namibia in the framework of "Learning for (Ex)Change".

The year 2022 was a lively and eventful year, packed with activities across the different fields of activity of the ZASB. Looking back, 2022 seems to have made up for at least some of the shortcomings of the previous years, which were dominated by the Covid-19 pandemic. Accordingly, a first highlight of the year was the distinguished Carl Schlettwein Lecture presented by the eminent historian Toyin Falola (University of Texas, Austin), which, after a break of two years, could once again take place in a fully packed lecture hall, followed by a reception.

#### **Conferences**

Two major events marked the summer of 2022. The first was the conference of the German African Studies association, VAD, which took place from 8 to 10 June in Freiburg i.Br., Germany. It was organized by the Africa Centre for Transregional Research (ACT) at the University of Freiburg. The ZASB was involved as a partner and hosted both a reception at the conference venue and a concert at the Jazzhaus Freiburg on the evening of the first full conference day. Furthermore, many members of our network were active as panel conveners, presenters, and discussants. The conference was also a meeting point for current and former scholars and students from our network.

The second major event of the summer was the Second European Students' Conference on African Studies, held from 31 August to 2 September in Basel. The conference was organized by students of our MA program, with support from ZASB administrative staff and guidance from members of our research network. 72 participants from all over Europe - from Romania to Portugal and from Stockholm to Sardinia - but also from Cameroon and the Democratic Republic of Congo presented 24 papers grouped in eight thematic panels. The conference, which also featured workshops and exhibitions, was a great success. Beyond academic exchange it offered opportunities for networking and socializing, laying the basis for lasting friendships. The plenary was adamant that the event become a regular fixture.

#### **Graduate Network**

In August 2022, the fifth edition of our joint CODESRIA-ZASB Summer School took place in Dakar. 27 participants from 14 African countries presented and discussed their research. The focus was on the relationship between knowledge and politics, and participants critically discussed notions of normativity and objectivity in the social sciences.

A number of graduate workshops were held in Basel in the course of the year. One highlight was a workshop on photography, medicine, and health in the history of Africa at the end of May, which was organized by Danelle van Zyl in the framework of the SNSF Sinergia project "African Contributions to Global Health".

#### MA program

The Second European Students' Conference on African Studies mentioned above was not the only highlight for our MA students. The two final joint winter/summer schools, organized in partnership with the University of Namibia with support from the Mercator Foundation, brought together students from Basel and Windhoek to explore the transformation of food systems and the history of migrant labor in both countries. The results of the second winter/summer school were subsequently presented to the wider public in the framework of the Visual History Lab.

### **Research Network Africa**

We organized a second "Critical Reflection, Practices, and Ethics Day" as a one-day hybrid event for the members of our network and their international partners. The first Reflection Day in 2021 provided a long-sought platform to discuss and reflect on ethical issues in research practice and international collaboration, and a continuation of the event was sought by many. At the 2022 Reflection Day, discussions proved more practice-oriented than in the previous year, with one concrete outcome being the introduction of a first working group for Master's students embarking on their thesis in the framework of the MA African Studies in the summer semester of 2023.

In March 2022, the ZASB's first Regional Day on the Horn of Africa, organized by Natalie Tarr and Sonja Merten, brought together young and established researchers. In October, the ninth Namibia Research Day, co-organized with the Basler Afrika Bibliographien and the School of Humanities, Society and Development of the University of Namibia, offered students and researchers four thematic sessions ranging from Decolonial Museum Developments to Queer Activisim.

of an SNSF project on "Cultural Relations between Switzerland and South Africa." Finally, the conference "Conjunctions of Archives and Public Spheres" will be organized in partnership with the Swiss Society for African Studies, which will also hold its General Assembly in Basel on the occasion of this conference.

#### Afrika-Bulletin

In collaboration with the Afrika-Komitee we published four issues of our quarterly *Afrika-Bulletin* on political icons, Ethiopia, the right to the city, and global health respectively. The latter featured contributions based on essays written by MA students in a course on African Contributions to Global Health.

#### **Outlook**

We are looking forward to organizing a major conference in 2023: Together with the Department of Social Sciences, the ZASB will host the biennial conference of the Swiss Association for the Studies of Science, Technology & Society. Our engagement is aimed at promoting exchange between African Studies in Basel and Switzerland with another interdisciplinary research area, namely Science and Technology Studies. On the one hand, we hope for new impulses in timely debates about the historical and social conditions of knowledge production, a key issue in African Studies; on the other hand, we are convinced that African Studies will bring new perspectives and approaches to Science and Technology Studies.

Our sixth Summer School in African Studies will take place in the run-up to the conference on the theme of "Making knowledge policy-relevant: The SSH's role in global sustainable development." The participants will have the opportunity to present their reflections on this topic to a national and international audience at the conference.

Additional smaller conferences in 2023 will mark the centenary of African Studies pioneer Hans W Debrunner and the conclusion





In 2002, the University of Basel introduced the interdisciplinary MA program African Studies. Drawing on the social sciences, humanities, and natural sciences, the program equips students with the necessary in-depth knowledge and skills to allow them to engage with Africa in an interdisciplinary and transdisciplinary way. By the end of 2022, 135 students had graduated from the African Studies program.

In my opinion, the most significant aspect of the process of organizing a conference is the importance of generosity and humanity towards the participants. In this regard, support from our funders and the University allowed us to make a difference by supporting participants who lacked sufficient funds for accommodation and travel, assisting African participants to get their visas, and levying modest registration fees. Before SESCAS, I was not aware such support might be available and was thus discouraged from joining international conferences. How could I possibly afford the air ticket? How would I get a visa? How could I afford the living expenses in a high-income country? It is the conference organizer who, ideally, connects various resource providers, makes the impossible possible, and ultimately connects minds.

However, the year-long process also presented some challenges. From a very ambitious plan to a smaller but executable project, there were many rounds of discussion marked by anger, tears, and frustration but also by laughter. Teamwork is never simply a slogan. All of us were working part-time on the project and had to deal with heavy workloads from our studies. In order for such a project to succeed, mutual understanding is of greatest importance—a big thank you to all my teammates!

Being part of the SESCAS organizing team was definitely both challenging and beneficial on various levels. Nothing would have been possible without a strong set of core values. One of our key principles was to engage with students around the globe, trying to break the barriers imposed by studying in Europe, which can sometimes imply the bias of researching from a European point of view.

Another important aspect was to find balance. We wanted to provide access to valuable academic knowledge and to create a lasting network of students (i.e. future scholars) interested in African Studies, while at the same time facilitating a suitable dynamic environment where students would feel safe, heard, appreciated, and, ultimately, encouraged to continue their research. We achieved this balance not least thanks to direct and indirect input from our former colleagues, facilitators and moderators.



In 2013, the ZASB, together with the Research Priority Program Asia and Europe at the University of Zürich, was awarded SUK (to-day swissuniversities) funding for the joint Graduate Module "Challenges in Interdisciplinary Area Studies." In Basel, the graduate module developed into a lively community, supporting training for and individual research activities by PhD students within the African Studies network. This formed the basis for the implementation of the swissuniversities-funded Basel Graduate Network African Studies in 2017. Between 2013 and 2022, a total of 95 young researchers affiliated with the Graduate Module or the Graduate Network completed their PhDs at different faculties of the University of Basel.

Membership fees: ZASB is a member of the Africa-Europe Group for Interdisciplinary Studies AEGIS, the Swiss Society for African Studies SSAS, and Friends of the Archives (supporting access of students to the archives of Mission 21).

**MA course:** 75 percent of the expenses are salary costs for tutors supporting hybrid teaching.

**Staff:** Mostly costs related to welcoming new staff members, send-off events, as well as training events.

**Publications:** These include the Afrika-Bulletin and contributions to publications from our network members.

**Student exchange:** In the past year, there were no applications of incoming or outgoing students.

**Events:** The main expenses were for the ZASB's presence at the conference of the German African Studies Association VAD in Freiburg i.Br. and for the Carl Schlettwein Lecture. Other events included the Regional Day on the Horn of Africa, PhD workshops, the events in connection with the "Ways of Reading after the Fire" project, and the ZASB Reflection Day.

Conference participation: Support of conference participation of staff and network members, especially in cases where the participants could not profit from the University's travel fund.

Advertisement and representation: This includes the production of the annual report of ZASB, welcome and farewell of visiting scholars and students, various meetings with partners and receptions.

**NB**: The overspending is balanced by reimbursements from the Swiss Society for African Studies to the amount of CHF 1,742.20, which means we are in fact slightly under budget.
