Part I: Institutional relations and their contributions to African Studies

Livio Sansone holds Bachelor degree in Sociology - Universita degli Studi La Sapienza (1980), a Master's degree in Anthropology - Universiteit van Amsterdam (1986) and a PhD degree in Anthropology - Universiteit van Amsterdam (1992). Sansone has been living in Brazil since 1992, where he is full Professor of Anthropology at the Federal University of Bahia (UFBA). He is the head of the Factory of Ideas Program – an International Advanced Course in Ethnic and African Studies – and coordinates the Digital Museum of African and Afro-Brazilian Heritage. He has published extensively on Youth Culture, Ethnicity, Inequalities, International Transit of Ideas of Race and Anti-Racism, Anthropology and Colonialism, and Globalization with research based in the UK, the Netherlands, Suriname, Brazil, Italy and, more recently, Cape Verde, Senegal, Mozambique and Guiné Bissau. His best known book in English is Blackness Without Ethnicity. Creating Race in Brazil (New York: Palgrave, 2003).

Gustavo Gomes da Costa Santos holds a BA in Social Sciences from the University of São Paulo (2003), a Master's degree in Political Science from the State University of Campinas (2006) and a Ph.D. degree in Political Science from the same institution (2011). He is currently Professor of Sociology and Researcher at the Graduate Programs in Sociology (PPGS) and Human Rights (PPGDH) at the Federal University of Pernambuco. He is also a Postdoctoral Fellow at the Free University of Brussels (ULB). He coordinates the Research Group *Diversiones* - Human Rights, Power and Culture in Gender and Sexuality and is a Member of the Atelier Gender(s) and Sexuality(s) at ULB. He has experience in the field of Political Sociology, with an emphasis on Social Movements, NGOs and Collective Action, Social Participation, Public Policies, Political Parties, Citizenship, Homophobia and Human Rights in Latin America and Africa. He also has experience in the area of Sexual Rights, Same-Sex Conjugality and State HIV/AIDS Policy.

He holds a Bachelor Degree in Social Sciences from the Federal University of Pernambuco (2004), a Master's degree in Sociology from the Federal University of Pernambuco (2007) and a Ph.D. degree in Sociology from the University of São Paulo (2012). He has worked mainly on the following themes: Race Relations, Affirmative Action, Quantitative Methods, Public Policy, Stratification and Social Mobility. He is currently a Visiting Professor at the Center for African Studies, where he is developing his research on "Social Stratification, Affirmative Action and Identity Economy: anti-racism dilemmas in contemporary Brazil" and developing activities in the area of social research methods.

Ana Gabriella Andrade holds a Master's degree in sociology and a Bachelor degree in law, both from the Federal University of Pernambuco (Brazil). She is a PHD Candidate in Sociology at the Federal University of Pernambuco and a researcher at the Institute for Latin-American Studies. Her doctoral research is related to social memory disputes among women during the 2018 presidential elections, in Brazil. She is currently a PHD visiting student at the University of Basel (Switzerland), where she is researching the role of social memory in contexts of political mobilization in Brazil and Mozambique. She has carried out studies on Political Sociology, Gender Studies and Development Sociology.

Sophia Branco holds a BA in Social Sciences from the Federal University of Pernambuco (2012), a Master's degree in Sociology from the same Institution (2018) and is a PhD Candidate in Sociology at the Federal University of Pernambuco (Brazil) and the University of Barcelona (Spain). Her Doctoral Research is about how Feminist Movements in Brazil have dealt with differences and inequalities among women in recent decades. He holds an MA degree in Translation and Interpreting (Salford), an MA degree in Sociology and Social Policy (University of North London) and a PhD and “Habilitation” in General Sociology (University of Bayreuth). He was Post-Doctoral Fellow at the University of Bayreuth, Research Fellow at the Centre for African Studies in Lisbon (Portugal), AGORA-Fellow at the Institute for Advanced Studies in Berlin and a visiting lecturer at Eduardo Mondlane University in Mozambique. He regularly offers methodological workshops to Portuguese speaking African doctoral students on behalf of CODESRIA (Council for the Development of Social Science Research in Africa).
